## Agreement Terms

1. **MODIFICATIONS, ADDITONS, AND CUTS:** *Haight* will be produced in its entirety. However, the theatre organization may make minor changes to adapt the show to its particular needs or circumstances.

Major changes must be approved by David Wendell Nelson. (for example, cutting of a song or sections of the dialogue)

Option 2. "Master Set". PDF version of the script. One master copy of the following (no binders): piano/vocal score, all vocal parts, all instrumental parts, production booklet, and full score. Cost: \$150

CDs are available of all songs and cues with or without vocals. Cost: \$15 per CD.
